"The prospective licensee has failed to meet the requirements for a Hotel Cocktail license pursuant to RSA 178:3, VII (b) & (f)."
RECOMMENDATION:
"The Division of Enforcement and Licensing shall not issue a liquor license to V.M.O. Inc. D/B/A Lake Shore Farm Inn due to the licensee's inability to operate the business in strict accordance with all applicable state and federal beverage control laws and rules, and the fact that the very nature of the business is not an appropriate one given its location and the town of Northwood's lack of resources."
The Licensee filed a Motion to Appeal the Denial of the License.
The hearings office continued the July 23, 2024 hearing.
The Licensee requested that the hearing be reopened to provide additional information.
