1) Welcome/Membership

2) Approval of the minutes

3) Division/Committee Reports

- A. Division Report / Bureau of EMS
- i) The Protocols Version 9.0 have been released; June is the deadline for adoption.
- ii) The State trauma plan was voted in by the TMRC and has been accepted by the Commissioner.
- iii) ETA Rules have been released.
- iv) EMR and simulation classes continue, Drew Toma will be stepping down from the simulation program but will complete classes already scheduled.
- v) Planning for a Statewide EMS Conference for 2025 is still underway.
- vi) Compliance has 38 active investigations currently.
- vii) 490 trauma kits have been distributed to select State buildings so far and is still ongoing.
- viii) 15 legislative efforts are being tracked by the Bureau of EMS and Fire.

 - (a) The MCB viewed the CARES presentation that Dr. McNally created.
- B. TMRC
 - (a) The TMRC approved the 2024 State trauma plan.
 - (b) The TMRC voted to recommend the State maintain a list of certified Stop the Bleed instructors.

- D. Stroke Care-Rebecca Cain
 - (a) May is stroke month, and Rebecca provided QR codes to encourage people to set up their medical IDs through their cell phones to help medical professionals in an emergency.
