Ongoing Initiatives


<u>Proposal Evaluation – 45 Proposals</u>

Proposals have been submitted seeking total funding of \$5.4 million in FY25. Staff will lead two teams of industry professionals and LCHIP board members in evaluating the proposals. Site visits to 43 project sites and two full-day meetings will lead to funding recommendations provided to the LCHIP Board of Directors, who will meet in mid-November to make the final funding decisions.
