*CALL TO ORDER BY CHAIRMAN:

*APPROVAL OF MINUTES – September 16, 2024:

*COMMUNICATIONS:

*CENSUS UPDATE:

Census/Admissions – As of October 18, 2024, we have 135 veterans in the Home: 123 men and 12 women.

*CAPITAL PROJECTS REPORT:

Commandant MacKay and COO Baker provided an update on the New Hampshire Veterans Home's capital projects and operations highlights:

- **NHVH New Addition** Commandant MacKay reported were notified on September 30, 2024, by the VA that we are on the list of priorities for their fiscal year and have been approved for funding for the new addition. We have the 100% design plan complete, and they have been approved by the VA and we anticipate going out to bid by the end of October.
- Parking Lot & Pond Paving Projects The deadline for this project was October 15, 2024, and they did not meet that. The Deadline has been extended to November 27, 2024, with the substantial completion date extended to May 9, 2025. They will need to have all parking lots paved, striped, all lights in, and ready for use.
 - Small projects to be continued and completed in the spring to include landscaping, interior courtyard walkways and the walkway around the pond.
- Overhang Canopy Project Department of Public Works (DPW) is in the final design process, waiting Fire Marshall approval before we can go out to bid on this project.

- **Sitewide Drainage Project** We are waiting for Eversource to unlock their vault to see if there is water in those. We are unable to complete our final design until then. It will take one to two weeks before they can be on site.
- Underground Fuel Storage Tanks We are looking at a couple different scenarios on this project. Whether to fix or have it removed. We are waiting on some estimates before a decision is made.
- Capital Budget Requests for FY26/27The Department of Public Works is assessing the following requests:
 - o Elevator replacement and repair.
 - Replacement of all the old tubs on units.
 - o 20 new ceiling lifts.
 - o LEDU Roof Air Handlers We were told we are unable to use the two new motors and drives that were just purchased and replaced, due to a new law passed regarding the type of coolant that is able to be used. We are no longer allowed to use the type of coolant we currently are using in those units. We are going to have to replace both entire units. We are working on a price for this.
 - o Tarr South remodel and ADA upgrades. We will be widening all the bathroom doorways and plans to remodel the rest of the unit.

*RESIDENT / STAFF MATTERS:

Diana Brown spoke to the Board about the kitchen and some of the processes that could be changed to better suite the residents. Dee thanked the Board for allowing her to be a member with them.

Commandant MacKay and Brian Baker let Dee know that we will be getting a new steam table that will improve the temperature of the food. We will be replacing the tables and chairs in the dining room as well. They are also looking into adding some tables into the Tarr South open area to add more space in the dining room for the residents to move around easier.
